GENERAL

Admission of membership will be governed by the Memorandum of Association and Rules & Regulations of CFI.

Note: - CFI will not divulge company specific data provided by the Member but will integrate and use the same for industry level aggregation.

MEMBERSHIP (Categories)

Membership is open in the following categories and new members will pay entrance fee and annual subscription along with the application for admission. Subscription for renewal of membership will be payable within thirty days of beginning of each Financial year.

- Patron members
- Ordinary Members (Indian companies, Indian Consultancy Organizations, Financial Institutions, Public Sector Undertakings and other such profit making bodies)
- Associates
- International Companies / Firms (Foreign Companies operating in India but not registered in India)
- Affiliates (Affiliated Association Members)
- Institutional Members

PATRON MEMBERS (Indian Companies / Firms / Body Corporates / Business Units)

Each Patron Member will make a one-time contribution of ₹ 5 Lakh + (Ser. Tax as applicable) with no entrance fee and the annual subscription as below and will nominate a representative.

ASSOCIATES

Companies / Firms having gross annual turnover of less than ₹ 10 Crore may apply for membership in the Associate category on payment of an entrance fee of ₹ 4000 +(Ser. Tax as applicable) and annual subscription of ₹ 10000 +(Ser. Tax as applicable) and they shall enjoy all the privileges of Ordinary Members other than voting rights. Representative Offices of Foreign Companies operating in India as Liaison Offices will be covered under this category and shall not have the right to vote.

INTERNATIONAL COMPANIES / FIRMS

Foreign Companies / Firms operating in India but not registered in India can become members of the Federation without any voting rights. Their annual subscription will be as follows:

AFFILIATES

Any Association operating in India whose aims and objects are similar or identical to those of CFI shall be eligible to become an 'Affiliated Member'. An Affiliated Association member shall pay an entrance fee of ₹ 4000 +(Ser. Tax as applicable) and annual subscription of ₹ 10000 +(Ser. Tax as applicable) towards such membership and shall not have the right to vote.

INSTITUTIONAL MEMBERS

Educational institutions, IT institutions, research and development institutions, all India professional institutes / organizations / boards relating to construction / other industry etc, can become 'Institutional Members' and such member shall pay an entrance fee of ₹ 4000 +(Ser. Tax as applicable) and annual subscription of ₹ 10000 +(Ser. Tax as applicable) and shall not have the right to vote.
